This draft ordinance would amend Chapter II of Article 1 of the Los Angeles Municipal Code (LAMC) to exempt Official Police Garages from the parking operator bond requirement, as directed by your Honorable Body.

ORDINANCE NO.

An ordinance amending Subdivision 4 of Subsection (d) of Section 21.15.6 of Article 1.15 of Chapter II, Parking Occupancy Tax, of the Los Angeles Municipal Code to exempt Official Police Garages from the parking operator bond requirement.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. Subdivision 4 of Subsection (d) of Section 21.15.6 of Article 1.15, Chapter II of the Los Angeles Municipal Code is amended to read as follows:

4. This bond requirement does not apply to an operator that is a governmental entity or an Official Police Garage as defined by Section 80.77.4 of Chapter VIII of this Code. However, this bond requirement is applicable to a non-governmental applicant operating a parking facility on behalf of a governmental entity.

Sec. 2. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
