I MOVE that the Council Actions of June 5, 2013 and June 25, 2013 relative to the transfer of \$500,000 in Council District AB 1290 funds for LA River projects (CF 12-0600-S179) BE RESCINDED, inasmuch as Council District One has identified alternate community priorities for these funds; and that, subject to the approval of the Mayor, this amount of \$500,000 be unencumbered, reverted to the Reserve Fund, be transferred therefrom to the Unappropriated Balance Fund No. 100-58 and be re-appropriated therefrom to the AB1290 Fund No. 53P, Account No. 281201 (CD 1 Redevelopment Projects - Services) to address community needs in Council District 1.
