ATTACHMENT TO THE BUREAU OF STREET LIGHTING 2012-13 PROPOSED BUDGET

Human Resources Consolidation – Phase 1 (Blue Book Item No. 26)

The Blue Book Item No. 26 shows a transfer of funding and regular authority for two (2) positions. However, only 1 position (Personnel Analyst II) provides full time personnel support to the Bureau as discussed in the Budget Hearing with the Mayor's Office and the CAO. The Clerk Typist included in the transfer performs other duties for the Bureau.

- Withdraw the addition of 1 position (Clerk Typist) and \$47,915 in salaries to the Personnel Department (Blue Book item 26) from the proposed budget.
- Reinstate 1 position (Clerk Typist) Blue Book item 26, and apportion \$47,915 in salaries to the Bureau of Street Lighting, that would come from the withdrawal of the Personnel Department's Blue Book item 26.

Consolidation of Solar and LED Decorative System

The Bureau has requested the reclassification of one Street Lighting Engineering Associate III to a Street Lighting Engineer. The Street Lighting Engineer will oversee the Transportation Grant Funded projects, Bikeway projects and the Solar Street Lighting program. The upgraded position will oversee the expansion of the LED decorative implementation program which will address the remaining 70,000 streetlights in the City that will not be part of the overall LED Energy Efficiency Conversion and to the new advances in solar to grid for street lighting applications. These two areas have increased the workload and level of responsibility needed to oversee the testing, review, approval and deployment.

This request was approved in the Budget Hearing with the Mayor's Office and the CAO.

 Reallocate one (1) Street Lighting Engineering Associate III to a Street Lighting Engineer to address operational needs.
