On February 16, 2007, in accordance with the Workforce Investment Act of 1998 (WIA), the City of Los Angeles and the Workforce Investment Board of the City of Los Angeles (WIB)/Local Elected Officials (LEO) executed an agreement - the WIB-LEO (Contract No. C-111328) (C.F. 05-0167). The WIB-LEO agreement, effective for the period February 16, 2007 through February 16, 2012, is a requirement of the WIA legislation and defines the roles, responsibilities and working relationship of the WIB, the WIB administrator (the Community Development Department [CDD]), the Mayor and the City Council in administering WIA programs for the City. The Agreement was extended by Council action through August 16, 2012.

On August 7, 2012, the Council approved a two-month extension of the WIB-LEO agreement which will expire on October 16, 2012 (C.F. 12-0602-S1). Staff requests additional time to meet and finalize the negotiations of the agreement. To validate WIB/CDD workforce development activities occurring after October 16, 2012, avoid a break in program services, and serve the best interests of the City and its residents, the City Council should authorize an extension to the WIB-LEO by six months from October 16, 2012 to April 16, 2013.

I THEREFORE MOVE that the City Council, with the concurrence of the Mayor, extend WIB-LEO Agreement by an additional six months from October 16, 2012 to April 16, 2013.
