DEVELOPMENT MAY 15 2012

On February 16, 2007, and in accordance with the Workforce Investment Act of 1998 (WIA), the City of Los Angeles and the Workforce Investment Board of the City of Los Angeles (WIB)/Local Elected Officials (LEO) executed an agreement - the WIB-LEO (Contract No. C-111328) (CF 05-0167). The WIB-LEO agreement, effective for the period February 16, 2007 through February 16, 2012, is a requirement of the WIA legislation and defines the roles, responsibilities and working relationship of the WIB, the WIB administrator (the Community Development Department [CDD]), the Mayor and the City Council in administering WIA programs for the City.

The WIB-LEO lapsed on February 16, 2012. To validate WIB/CDD workforce development activities occurring after February 16, 2012, avoid a break in program services, and serve the best interests of the City and its residents, the City Council should authorize an extension to the WIB-LEO by six months from February 16, 2012 to August 16, 2012.

Additionally, given that the WIB-LEO has expired, the Council should instruct the Community Development Department (CDD) and the WIB to transmit the WIB/LEO agreement to Council for review and approval, instruct the Office of the Chief Legislative Analyst to review the WIB/LEO document and consult with representatives of the WIB, Mayor's Office, City Administrative Officer and CDD, and report to Council with recommended changes.

I THEREFORE MOVE that the City Council, with the concurrence of the Mayor:

1. Authorize an extension of the WIB-LEO by six months from February 16, 2012 to August 16, 2012.
2. Instruct the Workforce Investment Board and the Community Development Department to transmit the WIB/LEO agreement for Council review and approval in two weeks.
3. Instruct the Office of the Chief Legislative Analyst to review the WIB/LEO agreement and consult with representatives of the WIB, Mayor's Office, City Administrative Officer and CDD, and report to Council with recommended changes.
