Council Action

The City Council ADOPTED the following recommendation(s), contained in a COMMUNICATION FROM THE LOS ANGELES HOUSING DEPARTMENT which were WAIVED, pursuant to Council Rule 17, by the Chair of the Housing, Community and Economic Development Committee, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. AUTHORIZE the General Manager, LAHD, or designee, to execute a contract amendment with David Paul Rosen & Associates (C-119157), to add scope of work, add eight months to existing contract term through December 31, 2012, and increase funding by \$70,000, subject to the approval of the City Attorney as to form.
2. AUTHORIZE the Controller to expend funds for David Paul Rosen & Associates from HOME Fund No. 561/43, Account A844 for \$70,000, for Fiscal Year 2011-12.
3. AUTHORIZE the General Manager, LAHD, or designee to prepare Controller instructions and make any necessary technical adjustments consistent with Mayor and City Council actions on these programs, subject to the approval of the City Administrative Officer, and AUTHORIZE the Controller to implement these instructions.
