NOTICE OF PUBLIC HEARING
The Los Angeles City Council will conduct a Public Hearing relative to an Ordinance amending Article 4 of Chapter XVI of the Los Angeles Municipal Code to amend the City of Los Angeles Foreclosure Registry Program to establish an inspection fee on foreclosed properties as follows:
(1) A non-refundable annual registration fee in the amount of \$155 shall be paid to the Los Angeles Housing and Community Investment Department (HCIDLA) by any beneficiary or trustee who holds or has an interest in a deed of trust on a property in foreclosure located within the City of Los Angeles within 30 days of the issuance of a notice of default.
(2) A proactive inspection fee in the amount of \$356 shall be paid by the beneficiary or trustee who acquired the property when a registered property's status changes to indicate that the foreclosure process against that property is complete.
The hearing will be held on Wednesday, November 12, 2014 at 10:00 a.m., or as soon thereafter the matter can be heard, in the John Ferraro Council Chamber, Room 340, City Hall, 200 North Spring Street, Los Angeles, California 90012.
