I HEREBY MOVE that Council ADOPT the following recommendation (Item #5, Council file 12-0782) relative to the establishment of the Century City Property and Business Improvement District (BID), pursuant to Section 53753 of the California Government Code, Section 36600 et seq. of the California Streets and Highways Code and Article XIII D of the California Constitution, SUBJECT TO THE APPROVAL OF THE MAYOR:
