Dear Mr. Rosendahl:

We own the property at 136-142 Barrington Place and are a member of the expiring B.I.D. Like many people situated north of Chayotte on Barrington Place we would like to be excluded from the next B.I.D.

As a member of the expiring B.I.D. during the past ten years we have concluded that the value we receive from our membership is practically nil compared with the extra property tax burden imposed on us to support the B.I.D. In our section of Barrington Place, which slopes downward to the north toward Sunset Boulevard, we have sub-par landscaping, particularly with respect to trees. Actually, for the most part we don't have trees; we have spindly saplings which don't survive and mature into trees. The spindly saplings are not wired for lights during the Christmas season, such as the rest of the village enjoys. Our B.I.D. taxes are also used for sidewalk cleaning, which we would prefer not to have, due to the fact the down-slope of the street often sends the wash water under our doors. Another service which our B.I.D. taxes fund is trash pick-up; however, this is of little or no value to us because our tenants have their own refuse collection service. And, of course, our share of the overhead cost of the B.I.D. is a dead loss insofar as we are concerned because we receive almost nothing useful from the B.I.D.

We would appreciate it very much if you could find a way to exclude us from the next B.I.D.
