

I'm writing this in support of the "Optimum Investment" Park Ranger option in reference to two different files: 1. APHAR Committee meeting 2/10/14 - Agenda Item 7, and 2. Council File 12-0899-S1

I live right next the Sepulveda Basin Recreation Area. I walk to Beilenson Park / Lake Balboa four times a week, and have done so for years. I am also now visiting the Sepulveda Basin Off Leash Dog Park. A commonality between these parks is the lack of supervision and security, an authoritative presence, protection of public property and park facilities, and a go-to for questions and information.

We have beautiful parks that need to be respected and properly serviced. There is no on-site patrolling. The park rules that are meant to protect the people and pets that visit and use the park, and the wildlife and the parkland itself, are routinely ignored.

The job description of Park Rangers, and the tasks they perform are exactly what are needed in our Parks. No one other profession can do so much for our parks for such a relatively low cost, as compared to multiple employees to perform all the tasks that Park Rangers do, including:

- Law Enforcement
- Public Assistance
- Naturalist and Interpretive
- Fire and Rescue
- Communications
- Special Tasks and Teams
- Mounted Unit
- City Emergencies
- Homeless Encampments
- Part-Time Security Officers
- Observatory

All this and Public Outreach too! The "Optimum Investment" Park Ranger option seems to be the obvious, "no brainer" solution to what is and has been, an on-going problem. I beg you to please act in favor of the "Optimum"

Investment" Park Ranger option!

Park Rangers have traditionally had a broad range of duties from putting out fires to finding lost children.
