## County Counsel - Los Angeles County

The Office of the County Counsel and its 250 lawyers serves as attorney for and provides legal advice and representation to the Los Angeles County Board of Supervisors, County departments, and other public officers and agencies. One hundred of the lawyers practice in Dependency Court representing the Department of Children and Family Services, in protecting the best interests of the more than 35,000 children in its jurisdiction. The advice to and litigation for the more than 40 departments includes the law of contract, tort defense, Brown Act and election law, medical malpractice, financing, labor and employment, federal civil rights defense, probate, environment, real estate, Public Records Act, and Workers' Compensation.

#### June 2005 – February 2010

#### Member:

Member, Los Angeles Board of Police Commissioners, the civilian oversight board for the Los Angeles Police Department. (Appointed four year term September 2005). Under the City Charter, the Board of Police Commissioners is the head of the Police Department. The Board sets overall policy while the Chief of Police manages the daily operations of the Department and implements the Board's policy direction and goals. Although a volunteer position, members typically spend 15-20 hours per week, guiding the policy and assisting in management of the Department.

#### January 1983 – January 1991

Chief Assistant Attorney General, State of California, Division of Public Rights. Responsibilities included supervision of the 140 lawyers and other professionals in the Division, which included the Antitrust, Consumer Protection, Environment, Natural Resources, Lands, Charitable Trust and Civil Rights Sections.

Responsible for the management of the Division's litigation and legislative advocacy. Appeared periodically in the trial and appellate courts, arguing Nollan v. Coastal Commission, in the United States Supreme Court; California v. Levi Strauss, in the California Supreme Court, and California v. American Stores, in the District Court, and sitting second chair in the case in the United States Supreme Court.

During the eight years of the administration, the Office made unprecedented gains in recruiting and appointing women and people of color throughout the office and in the Public Rights section. Persons of color and women were assigned the most coveted and competitive positions in the office, including leadership position in the Environment, and Civil Rights sections.

#### October 1977 – November 1981

United States Attorney for the Central District of California, the third woman in history to be appointed by the President to the position. Responsibilities included the supervision of the 95 Assistant U.S. Attorneys assigned to the Criminal, Civil and Tax Divisions in Los Angeles and oversight of the Department of Justice lawyers trying cases in the District. The Central District of California includes the counties of Los Angeles, Orange, Riverside, San Bernardino, San Luis Obispo, Santa Barbara and Ventura. Appeared periodically in the Ninth Circuit on civil and criminal appeals. Developed and chaired joint state, local and federal task forces to enforce criminal and civil rights laws.

Participated as a member and Chair of the Attorney General's Advisory Committee. The Advisory Committee, comprised of 15 representative United States Attorneys, met six times a year with the Attorney General, the Deputy Attorney General, the Associate Attorney General and other members of the Department to advise them on policies and procedures of the Department of Justice.

### 1975 - 1977

Assistant District Attorney of Los Angeles County, the third ranking position in an office of more than 550 lawyers and approximately 1,500 investigative and support personnel. In addition to general administrative responsibilities, the Assistant District Attorney had specific administrative responsibility for the more than 60 lawyers in the Juvenile Division, the lawyers assigned to the Special Investigations Division, which investigates charges of police malpractice and governmental corruption, and the lawyers in the Consumer and Environmental Protection Divisions.

Participated in drafting the first Affirmative Action program for the District Attorney's office, as well as the first grant proposal for the Hard Core Gang Vertical Prosecution program.

### <u> 1965 – 1972</u>

**Deputy Attorney General, State of California**, assigned to the following Sections: Criminal Appeals, Consumer Protection and Constitutional Rights. Handled both civil and criminal trial and appellate cases for the Sections, handling more than 60 State court appeals, including four arguments before the California Supreme Court expanding the rights of California consumers.

### **Private Practice**

#### March 1983

Partner and Senior Counsel, Morgan, Lewis & Bockius, Los Angeles, California. Partner from 1995 – 2005 and formerly Partner in charge of 60 person Litigation Department in Los Angeles. Charged with managing Morgan Lewis, Los Angles and Orange County pro bono programs.

Practice focused on complex business, environmental litigation and internal corporate investigations. Appears regularly in State and federal courts. Co-chaired and obtained a unanimous defense verdict for the firm's client after a 3-week jury trial in which plaintiff had alleged \$300 million in consequential damages. Significant representations included:

- Defense of multi-national companies against claims of antitrust violations.
- Defense of shippers and terminals in Los Angeles and Long Beach against claims of violations of Proposition 65.
- Internal investigation and subsequent litigation resulting from claims of fraud and embezzlement of employee of a major trade association.

To do so, please bring this letter to the Background Unit of Employment Services Division, Personnel Department Building, 700 East Temple Street, Room 235, Los Angeles, (213) 473-9343. Fingerprints must be taken within three working days from the receipt of this letter.

Under separate cover you will be receiving a packet from the City Ethics Commission containing information about the City's conflict of interest laws and a copy of the State Form 700/Statement of Economic Interests. City law requires that you complete and return this form **within 21 days** of your nomination to the City Ethics Commission, 200 North Spring Street, City Hall, 24th Floor, Los Angeles, California 90012. Commissioners must be residents of the City of Los Angeles. If you move at any point during your term, have any changes in your telephone numbers, or in the future plan to resign (resignation must be put in writing), please contact my office immediately.
