

ORDINANCE NO. 183160

An ordinance establishing the special tax amounts to be levied on parcels within Community Facilities District No. 4 (Playa Vista - Phase 1) for Fiscal Year 2014-2015.

WHEREAS, the Los Angeles City Council adopted Ordinance No. 172,784 (Ordinance of Formation), which established Community Facilities District No. 4 (Playa Vista - Phase 1) (District), to refurbish the Playa Vista area of the City of Los Angeles, and authorized the levy of a special tax pursuant to the Mello-Roos Community Facilities Act of 1982, as amended, consisting of California Government Code Sections 53311, *et seq.* (Act); and further authorized the issuance of bonds (Bonds) secured by the special taxes to finance refurbishment of the Playa Vista of area;

WHEREAS, the Council adopted Ordinance No. 174,037, which authorized the levy of a special tax within the District on an annual basis until the special tax is paid off;

WHEREAS, it is possible that the District will refund the Bonds by issuing refunding bonds (Refunding Bonds) to lower debt service and thereby reduce the special tax amounts, and it is therefore desirable to allow for a new annual levy under such circumstances; and

WHEREAS, the Council, acting in its capacity as the legislative body of Community Taxing District No. 4 (Playa Vista - Phase 1), adopts this ordinance.

NOW, THEREFORE,

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**


Section 1. An annual special tax on the parcels (Parcels) of property within the District is hereby levied for Fiscal Year 2014-2015, at the specified amount for each Parcel of property, identified by Assessor Parcel Number, all as described in the attached Exhibit "A," except that: (i) no special tax is levied on any parcel of property for which the special tax has been prepaid, discharged and permanently satisfied in accordance with the District's Ordinance of Formation or Ordinance of Annexation; and (ii) in the event any parcel of property is renumbered, subdivided or consolidated with another parcel of property, the special tax applicable to the former Assessor Parcel Number shall be ratably levied on the new Assessor Parcel Number(s) resulting from the renumbering, subdivision or consolidation.

Sec. 2. If the Refunding Bonds are issued, the City Administrative Officer shall submit to the Los Angeles County Assessor an annual special tax on the Parcels for the Fiscal Year 2014-2015 (Reduced Tax Levy) in lieu of the annual tax levy described in the attached Exhibit "A," provided that the amount of special tax on each Parcel is less than the amount shown on the attached Exhibit "A," and the Reduced Tax Levy is submitted to the Los Angeles County Assessor in time to be included on the tax rolls for Fiscal Year 2014-2015.

Sec. 3. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulleting board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulleting board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
