ENERGY AND ENVIRONMENT COMMITTEE REPORT relative to authorizing the execution of Amendment No. 3 to Agreement No. 47894 with Five Point Partners, LLC for quality assurance services for the Customer Information System Replacement project.

Recommendation for Council action:

CONCUR with the Board of Water and Power Commissioners' action of July 17, 2012, Resolution No. 013-015, approving Amendment No. 3 to Agreement No. 47894 with Five Point Partners, LLC that extends the term approximately eight months, expiring on April 30, 2013, in order to continue quality assurance services for the Customer Information System Replacement project.

Fiscal Impact Statement: The City Administrative Officer reports that approval of the proposed resolution will extend the term of the current agreement for approximately eight months and no additional funding requested. The proposed Agreement complies with the Department's adopted financial policies. Approval of the proposed resolution will have no impact on the City's General Fund.
