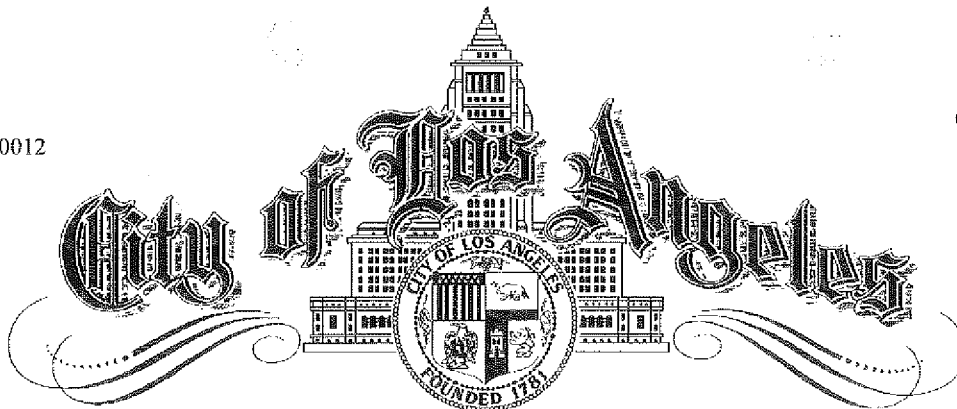

MUNICIPAL CODE TO CHANGE THE SPEED LIMIT ON SUNLAND BOULEVARD**

Pursuant to standing instructions from the City Council and at the request of the Department of Transportation, this Office has prepared and now transmits to you for your consideration, approved as to form and legality, a draft ordinance amending Los Angeles Municipal Code Section 80.81 to change the speed limits on certain portions of Sunland Boulevard in Council Districts 2, 6 and 7, to establish 40 and 45 miles per hour speed limits, in order to ensure radar enforcement. We sent a copy of this draft ordinance to the Los Angeles Police Department, which recommended adoption, in compliance with Council Rule 38. This draft ordinance was previously approved by the Board of Transportation Commissioners.

ORDINANCE NO. \_\_\_\_\_

An ordinance amending Section 80.81 of the Los Angeles Municipal Code to change the speed limits on Sunland Boulevard in the City of Los Angeles.

**THE PEOPLE OF THE CITY OF LOS ANGELES  
DO ORDAIN AS FOLLOWS:**

Section 1. Subdivision S of Subsection (2) of Section 80.81 of the Los Angeles Municipal Code is amended by deleting the following:

On Sunland Boulevard from Nettleton Street to Tuxford Street.

Sec. 2. Subdivision S of Subsection (3) of Section 80.81 of the Los Angeles Municipal Code is amended by adding the following, in alphabetical order:

Sunland Boulevard between Nettleton Street and Sunland Park Drive, and between Nohles Drive and Foothill Boulevard / Newhome Avenue.

Sec. 3. Subdivision S of Subsection (4) of Section 80.81 of the Los Angeles Municipal Code is amended by deleting the following:

On Sunland Boulevard between Foothill Boulevard and Tuxford Street.

Sec. 4. Subdivision S of Subsection (4) of Section 80.81 of the Los Angeles Municipal Code is amended by adding the following, in alphabetical order:

Sunland Boulevard between Sunland Park Drive and Nohles Drive.

Sec. 5. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
