1. PRESENT and ADOPT the accompanying ORDINANCE establishing the Greater South Park Property and Business Improvement District and confirming the assessments to be levied upon properties within the BID, as described in the Management District Plan.
2. AUTHORIZE the City Clerk, subject to approval of the City Attorney, to prepare, execute and administer an operating agreement between the City and the South Park Stakeholders Group, Incorporated, for administration of the District.


The Greater South Park Property Business Improvement District requests a technical amendment to restore consistency with the prior management district plan and services, as well as consistency with other parcels on Margo Street. The attached revised Management District Plan and Engineer's Report move the South Park Property Business Improvement District boundary line on Margo Street south of Pico Boulevard from the center of Margo Street to the property lot line on Margo to keep the boundary on Margo consistent with the existing boundaries.

The appropriate legal descriptions of the boundary have been amended in the revised October 2nd Management District Plan and Engineer's Report to reflect this change.

I THEREFORE MOVE that the matter of the adoption of the Ordinance First Consideration, Item No.5 on today's regular Council Agenda (CF 12-1168) BE AMENDED to adopt the following additional recommendations:
