Re: Approval of Reallocation of Funds for Fiscal Year 2012-13 for the 2009 American Recovery and Reinvestment Act Edward Byrne Memorial Justice Assistance (JAG)
Grant Program (Council File No. 09-0648-S5)

Dear Honorable Members:

On November 20, 2009, City Council approved the spending plan and authorities to accept the Department of Justice (DOJ), Bureau of Justice Assistance (BJA) FY 2009 American Recovery and Reinvestment Act Edward Byrne Memorial Justice Assistance Grant (FY09 ARRA JAG) in the amount of \$30,514,178. On March 18, 2011, City Council approved the remaining \$7,051,983.50 million spending plan. The original performance period end date for the grant was February 28, 2013, and an extension of the grant was approved by DOJ on May 26, 2011. The new end date is February 28, 2014, which was approved by Council on August 17, 2011.

Transmitted herewith is a request for: 1) approval to reprogram interest income earned from this grant fund in the amount of \$210,679.98 to be utilized in FY 2012-13 to support the Community Law Enforcement and Recovery (CLEAR) program; and 2) approval to enable the City to move \$70,000 from the LA-RICS/Tower Improvement Project's contractual services account into the overtime account for the Information Technology Agency (ITA). Because of the earned interest, the new grant award budget is \$31,110,625.72

The City of Los Angeles, as a direct recipient of the FY09 ARRA JAG grant, is required by the grantor to establish an interest-bearing account in which to deposit grant funds. Per the Department of Justice, JAG recipients are entitled to reprogram earned interest income to expand and support approved grant programs. We propose to utilize the \$210,679.98 in accrued interest to supplement the salaries for three City Attorneys assigned to the CLEAR program in FY 2012-13.

During FY 2010-11, the FY09 ARRA JAG provided \$189,014 to support the salaries for two Deputy City Attorneys (DCAs) assigned to CLEAR in Southwest Division and 77<sup>th</sup> Division. In FY 2011-12, \$374,532.74 in interest earned on the grant supported the salaries of nine DCAs in all nine LAPD divisions (Northeast, Newton, Southeast, Southwest, Foothill, 77<sup>th</sup>, Rampart, Ramona Gardens, and Boyle Heights). In FY 2012-13, the \$210,679.98 will support the salaries for three DCAs assigned to CLEAR in three LAPD divisions (Southwest, Ramona Gardens, and Boyle Heights). Additional funding for CLEAR in FY 2012-13 is anticipated to come from two other grants: the FY 2012 Juvenile Accountability Block Grant (\$168,728) and the FY 2012 Edward Byrne Memorial Justice Assistance Grant (amount TBD). Our office is in the application stages of the FY 2012 Edward Byrne Memorial Justice Assistance Grant (JAG 12) and therefore the budget for the CLEAR program under this grant is not yet finalized. We will return to Council with a detailed JAG 12 budget once it is finalized.

Below is a chart outlining the anticipated grant funding available for the City Attorneys assigned to the CLEAR program in FY 2012-13. Although the chart is currently incomplete, we plan to have a more complete picture once the JAG 12 budget is determined. The general fund will cover the remaining salary costs.

The CLEAR program was established in 1996 as the City's primary gang suppression program. CLEAR has been the suppression component of the Mayor's Gang Reduction Strategy that was introduced in April 2007. The primary purpose of CLEAR is to facilitate the recovery of gang-infested communities. This is accomplished by decreasing the criminal activity of targeted gangs in designated communities through an effective collaboration with City and County criminal justice agencies. The CLEAR Team includes the Los Angeles Police Department (LAPD), Los Angeles County Probation Department, Los Angeles City Attorney, Los Angeles County District Attorney, and the California Department of Corrections Parole.

## Tower Improvement Project

On August 19, 2011, Council approved the reallocation of \$300,000 towards Contractual Services for the transferring and relocation of communication and antenna equipment from existing shelters or towers into the new structures. As stated in that report (Council File No. 09-0648-S5), the grant project is a stand-alone tower improvement project that will eventually be compatible with the larger Los Angeles Regional Interoperable Communications System (LA-RICS) project. We are now requesting that \$70,000 be moved from contractual services into Information Technology Agency's (ITA) overtime account, bringing the total for ITA's overtime charges to \$70,000.

The FY09 ARRA JAG grant is funding the construction of a new microwave shelter facility at the site, which currently supports the LAX, South East, South West, and Pacific Police Divisions. The funds are for the telecommunications upgrades that are in process at the Baldwin Hills telecommunications site. Through the standard RFP process as outlined and approved in the August 19, 2011 transmittal, a vendor was selected for the relocation work to be done at the Baldwin Hills site. The current facility on the site will be demolished in order to make space for the new building. Before the demolition can occur, the existing microwave radio equipment must be relocated without interrupting service. A vendor has been procured to assist in the relocation of this sensitive equipment. Before the relocation by the vendor can occur, ITA PiperTech personnel will need to reroute the existing radio traffic, so that there is no down-time or interruptions to service during the relocation and construction. The overtime funds are dedicated to this purpose.
