

The Granada Hills North Neighborhood Council (GHNNC) at the scheduled Board meeting September 24, 2012 considered the above file 12-1282, introduced by Councilman Richard Alarcon.

The council considered that although there may be a need for some residents of the city to obtain identification cards, the GHNNC noted that there are other avenues to obtain identification cards and that the library should not be turned into Financial Literacy Centers, nor should the city enter into the Debit card business.

The following resolution was passed by the GHNNC Board with only one board member dissenting.

Resolved that GHNNC oppose the proposed use of the "City Services Cards" or Los Angeles Public Cards as city sponsored forms of identification other than its present use as a library card used at Los Angeles libraries.

Motion: (Hunter) - That GHNNC Board request that Governor Brown Veto California Assembly Bill 845 (Ma): Solid Waste Place of Origin and Assembly Bill 480 (Solorio): Insurance, Solid Waste Facilities. These bills will weaken California's existing requirements as it relates to the private landfill owners for local control and financial assurance. If passed, both of these Bills will have a detrimental impact on GHNNC stakeholders.
