TRANSPORTATION COMMITTEE REPORT relative to prohibiting the parking of over-sized vehicles during the hours of 9:00 a.m. through 3:00 p.m. on both sides of Wilshire Boulevard between Fairfax and La Brea Avenues.

Recommendations for Council action, as initiated by Resolution (LaBonge – Koretz):

- 1. RESOLVE, pursuant to California Vehicle Code Section 22507, to prohibit the parking of vehicles that are in excess of 22 feet in length or over 84 inches in height during the hours of 9:00 AM through 4:00 PM on the both sides of Wilshire Boulevard, between Fairfax and La Brea Avenues.
- 2. DIRECT the Department of Transportation (DOT), in consultation with Council District 4, to post signs giving notice of the parking restrictions on the both sides of Wilshire Boulevard, between Fairfax Avenue and La Brea Avenue.

<u>Fiscal Impact Statement</u>: None submitted. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

SUMMARY

On August 21, 2012, Council considered Resolution (LaBonge – Koretz) relative to prohibiting the parking of over-sized vehicles during the hours of 9:00 a.m. through 3:00 p.m. on both sides of Wilshire Boulevard between Fairfax and La Brea Avenues. Resolution states that the California Vehicle Code authorizes cities to restrict the parking of vehicles, including but not limited to, vehicles that are six feet or more in height, on identified City streets during all or certain hours of the day. To enact such restrictions, the governing body must approve a resolution or an ordinance, and post signs in the given area providing notice of said restrictions. Council referred resolution to the Transportation Committee for consideration.

At its meeting held September 12, 2012, the Transportation Committee discussed this matter with representatives of DOT, the City Attorney, and the food truck community. Committee recommended that Council approve the resolutions recommendations, as stated above.
