INSTRUCT Finance, during the next stage of procuring vendors through a Request for Proposal (RFP) that would provide collection services, to report the diversity of the vendors who responded to the upcoming RFP; the outcome of the outreach strategy utilized by Finance to cultivate interest from minority, women, and veteran owned companies; and, the participation and allocation of work based impart by the success of the vendor's collection efforts.

<u>Fiscal Impact Statement</u>: The City Administrative Officer (CAO) reports there is no General Fund Impact, and the funding is provided on a contingency fee basis to the Contractors from revenues recovered.
