Summary:

On February 5, 2014, your Committee considered a November 20, 2013 LADWP report relative to the second quarterly status update on the implementation of recommendations of the Independent Third Party Review associated with the Incremental Electric Rate Ordinance. According to the LADWP, the LADWP, as lead, in conjunction with the Ratepayer Advocate, Chief Legislative Analyst (CLA) and City Administrative Officer (CAO), are providing the second status report related to recommendations of the Independent Third Party Review. These recommendations were adopted by the Energy and Environment Committee on September 19, 2012, and Council on October 2, 2012, in connection with the approval of the LADWP Power System rate increase for Fiscal Years 2012-13 and 2013-14. This second report provides updates to the status of each recommendation supplementing the initial responses from March 2013 and a detailed summary of the LADWP's responses are provided in the November 20, 2013 LADWP report and attached to the Council file.

Representatives from the LADWP, Ratepayer Advocate, CLA, and CAO provided an overview of the responses to regard to the recommendations that arose out of the Third Party Review and answered questions from the Committee members. After consideration and having provided an opportunity for public comment, the Committee moved to note and file the November 20, 2013 LADWP report. This matter is submitted to Council for its consideration.
