



Your **HOUSING, COMMUNITY AND ECONOMIC DEVELOPMENT** Committee

reports as follows:

HOUSING, COMMUNITY AND ECONOMIC DEVELOPMENT COMMITTEE REPORT relative to authorization to negotiate and execute a contract with Hillview Mental Health Center for homeless facility improvements, in an amount up to \$500,000 in Community Development Block Grant (CDBG) funds.

Recommendation for Council action, pursuant to Motion (Alarcón – Krekorian), SUBJECT TO THE APPROVAL OF THE MAYOR:

1. AUTHORIZE the General Manager of the Community Development Department (CDD), or designee, subject to CDBG review and eligibility, to:
  - a. Execute a contract and ancillary documents with Hillview Mental Health Center, a nonprofit corporation, for up to \$500,000 in CDBG funds allocated to Sunland/Tujunga/Hansen Dam Homeless Facility Improvements and previously approved as part of the 39th Program Year (PY) (2013-14) Consolidated Plan in accordance with the City's Policy and Code of Federal Regulations, subject to City Attorney review as to form and legality.
  - b. Prepare Controller instructions and/or make any technical adjustments that may be necessary and are consistent with this action, subject to the approval of the City Administrative Officer, and authorize the Controller to implement these instructions.


SUMMARY

At a regular meeting held on April 17, 2013, the Housing, Community and Economic Development Committee considered Motion (Alarcón – Krekorian) relative to authorization for the General Manager, or designee, of the CDD to negotiate and execute a contract with Hillview Mental Health Center for homeless facility improvements, in an amount up to \$500,000 in Community Development Block Grant (CDBG) funds allocated to Sunland/Tujunga/Hansen Dam Homeless Facility Improvements and previously approved as part of the 39th PY (2013-14) Consolidated Plan.
