I MOVE that the Council action of February 27, 2013 relative to the allocation of Council District 8 CDBG funds for the Slauson Corridor Revitalization (CF 12-1607) BE AMENDED to reprogram the entire allocation of \$725,649 to the Council District 8 sidewalk reconstruction program, to be managed by the non-profit Los Angeles Neighborhood Initiative (LANI) for various eligible sidewalk reconstruction projects in Council District 8.

I FURTHER MOVE that the City Council:

1. Reprogram \$725,649 from Account 22K506 Slauson Corridor Renovation within the Community Development Trust Fund No. 424 to the Council District 8 sidewalk reconstruction program.
2. Authorize the General Manager, HCID to:
  - a. Amend the necessary Consolidated Plan(s) as required by HUD, including the posting of a 30-day public comment period;
  - b. Negotiate and execute a contract or contract amendment with LANI in the amount of \$725,649 for the Council District 8 sidewalk reconstruction program, subject to review of the City Attorney as to form; and
  - c. Prepare any additional Controller instructions that may be necessary and make any technical corrections that may be required to effectuate the intent of this motion, subject to approval of the Chief Legislative Analyst; and authorize the Controller to implement these instructions.
3. Authorize the Controller to take all necessary steps to establish accounts and other actions required to effectuate the intent of this motion.
