REQUEST AUTHORIZATION TO NEGOTIATE AND EXECUTE A NEW LEASE AGREEMENT WITH THE DEPARTMENT OF WATER AND POWER

The Department of General Services (GSD) requests authorization to negotiate and execute a new lease agreement with the Department of Water and Power (DWP) for a DWP owned facility at 14651 Oxnard Street in Van Nuys for use as the Valley CARES Family Justice Center (FJC).

The current lease expired on June 30, 2018 and is on a month-to-month holdover status. DWP is willing to execute a new lease with the City at zero rent for ten years to allow the FJC to continue its services. DWP staff state DWP Board approval is not required for a new lease due to the pre-existing relationship and existing lease history. Council District 6 is in favor of establishing a new lease agreement.

BACKGROUND

On October 26, 2012 GSD leased the facility from DWP for zero rent, and subsequently executed two nonprofit sub-leases to The University Corporation dba Strength United and Dignity Health dba Northridge Hospital Medical Center, for the purposes of operating the FJC (C.F. 12-1643).

The FJC is a unique, public-private partnership that links various agencies responsible for responding to child abuse and domestic and sexual violence. This multi-agency partnership has on-site staff consisting of a victim advocacy and counseling center, the Police Department (LAPD), City Attorney, a non-profit legal services agency, County District Attorney and the Center for Assault Treatment Services (CATS) provide invaluable assault victim services to the greater San Fernando Valley.



Strength United primarily operates and leads the FJC. The center is one of 80 Family Justice Centers in the country and the only one in Los Angeles County. It is a member of the National Family Justice Center Alliance, a rapidly growing movement across America that delivers efficient, effective, co-located, multidisciplinary services and is recognized as a best practice model by the U.S. Department of Justice in combating family violence.

Dignity Health is the fifth largest health care system in the nation and the largest hospital provider in California. Locally, it is a member of the 24 hour/seven day a week Sexual Assault Response Team (SART) program in the San Fernando and Santa Clarita Valleys that provides support for sexually and domestically abused women and children.

GSD will be requesting authority to enter into sub-leases with the two nonprofit organizations in separate reports through the Municipal Facilities Committee to City Council. Both nonprofit organizations are requesting new ten year leases. The current leases expired on June 30, 2018 and are on month-to-month holdover status.
