Michael L: The City Attorney has not gotten back to us on our issue of last month – which was members of this board who are on other boards, can they vote?

(j) OUTREACH COMMITTEE

Michael L: The last board wanted to put together an ad hoc committee to structure the funding process, with new procedures for people applying for our funds. As treasurer, Ashley is in charge of this.

8. ELECTION REPORT

Michael L: We got more turn out than previous years; about 800 people voted. It had controversy that made the news. For one thing people came from outside the neighborhood, by picking up some gum or bottle of water, showed their receipt then were eligible to vote. They did not vote on the slate, but from a flyer that circulated- so I understand from a dispensary in Rampart. The dispensary offered \$40 and some pot if you voted for their slate. I was volunteering at the election and I saw 30 or 40 people with those flyers and some were confused about what was going on and knew that this was what they were supposed to do; they were open about their confusion. The City and District Attorney are looking into it to see if they violated any laws, and the other problem was why they were able to do this – which was the "factual basis status" that relates to the Bylaws. Maria: Everyone was very orderly, even persons with flyers. We tried to help them as best we could. For the most part, most people were polite. There was one incident where police were called; I am not sure what the incident was. I was impressed by the checking and triple checking of voting for authentication to avoid any challenges. **Baker**. Do we know if any voters were turned away, and if so how many? Maria: I sent people away for validation, if they didn't have proof based on our Bylaws. Gracie Liu, DONE: We don't turn away anyone. They can do provisional voting and return with some proof a day or two later. Mike L: I heard poll workers advise people, the threshold is a receipt. Peter: It was an interesting day. I stayed there all day, even Nelson Grande stayed to the end. We stayed and watched the entire process up to the counting. DONE did a tremendous job. John Goldfarb, stakeholder: There's a link on Patch.com to the Bylaws, and I didn't see anything that a receipt was sufficient to vote. Maria: That got changed the night before the election by DONE. George Luke: It was my understanding that NCs can do things as it sees fit. I don't think DONE should define how things should be done. Tim Ryder, stakeholder: This factual basis came about because legitimate people who work and purchase here could not vote. When the City Attorney says no, they can't vote, I want people to know the history of how this came about. I don't want people to come from far away and vote, I am an Eagle Rock resident too. I didn't have anything to do with the flyer even though my name is on it. Why don't we have a fresh start with the medical marijuana thing? I am not here to fight.

Nelson Grande, stakeholder: I unsuccessfully ran for president. I am speaking on a personal level. Going forward if rules are changed as far as voter definitions, I suggest it be done before the elections. This group was disenfranchised before the election. These people shopped in our area often. I agree this is Eagle Rock and should be voted on by Eagle Rock residents. If anything I say in the future create those rules to define who a real stakeholder is before the election cycle begins, or it creates all kind of chaos for everybody. For Mr. Luke, regarding the receipt I want to be sure everyone knows, the actual Eagle Rock site said receipt from any business allows you to vote. Maria: That came from DONE, and was put on our site. Michael L: The word disenfranchised is a strong word. Let me give you some history. Tim Ryder wrote an article, where he asserted that people who shop in Eagle Rock are stakeholders. The City Attorney was asked to weigh in, and he said someone who wants to base their stakeholder legitimacy on a pot store, is not eligible, because the MMD business is illegal. That does not disenfranchise the 300 who buy some gum or water, then they become enfranchised; none were turned away. No one disenfranchised them. Nate Hayward, CD 14:A motion put forth by Councilmember Huizar was to limit factual basis to no more than 2 spots. This was for all councils. It happened to be this election issue that showcased the issue of factual basis. Unfortunately it was too little too late for this election. DONE is working hard on this. Right now it is important to go forward. I say people should submit opinions on how factual basis stakeholders should be defined and submit it to the ERNC board. Peter: We have to thank Nelson, for mobilizing this community. He took an issue and bought it to the forefront.

9. ERNC BYLAWS

<u>Michael L:</u>We want to go into the Bylaws and take care of this issue. DONE asserted that 2 years agopeople were warned about this issue, that it might be a problem. I don't remember it, or any communications from DONE about it. There is a push to limit the factual basis seats to 1 or 2 seats on the board and change the language so this does not happen again, so we are clear on who is a stakeholder.

I think we need an ad hoc committee to look at the Bylaws and recommend changes and DONE is doing a round of changes in January.

Ad Hoc Committee volunteers:

Kerry, Gregory, Jose, Liam, David and Michael L. Maria will share files and be available to help as will Alejandro. **Michael L:** DONE meeting with Gracie on the Bylaws is scheduled for Nov. 26 downtown.

<u>Gracie Liu, DONE:</u> DONE did not overlay anything on you. In terms of the Bylaws, we updated them to what was the current law. Unfortunately it was just before the election and it was to provide clarity about the matter. The stakeholder definition was passed by City Council in 2009, DONE has nothing to do with that. The City Clerk did an overlay onto the Bylaws, and most never got changed. <u>Tim Ryder:</u> Did you rule on the MMD issue? <u>Gracie</u>: The City Attorney basically gives us the ruling that if they brought anything from MMD shops it would not count. This is in light of the ban, then no ban, legal or illegal on MMDs issue.

10. COUNCILMEMER HUIZAR'S MOTION ON FACTUAL BASIS

Nate Hayward, CD 14: The reason the motion was introduced is because of what Gracie shared. The idea is to start a discussion as to what it means to be a factual basis stakeholder. You don't want to disenfranchise people, but you don't want to have people overrun an election who have no stake in the community. It is important to submit your opinions to DONE; as ERNC has to execute this in the next election. The Motion was introduced on Oct. 23rd, I don't know when it will be heard. Gracie: I told you that some NCs want factual basis stakeholders, others don't care.

MOTION by Liam recommending that the ERNC board support Councilmember Jose Huizar's motion File 12-1682 on Factual Basis Stakeholders and add a Community Impact Statement for the file. **SECOND** Gregory

Eddie: Not everyone has seen the motion; I don't know how we can vote on it. **Michael L**: This is a very important issue, and we don't meet for another month and it may be too late. The motion was attached to the November agenda.

VOTE:14 in favor. 2 Opposed: Jennifer and Baker. 0 abstain.

11. BOARD RETREAT

<u>Michael:</u> I suggest we take a few hours, go to the Coffee Table, get snacks, and take questions about being on the board. We can't talk about specific items, but about how things work. [Consensus was a week day evening.] Then let's allocate money for refreshments.

MOTION by Michael L recommending that the ERNC board approve up to \$250 for board retreat food.

SECOND: Kerry **VOTE**: Unanimous
