

SUBJECT: Protest Level Tabulation Results for the Renewal of the Wilshire Center Merchant-Based Business Improvement District for the District's 2020 Operating Year (CF 12-1696)

Listed below are the results of the tabulation of valid written protests to the levying of assessments for the Wilshire Center Merchant-Based Business Improvement District ("District") for the District's 2020 operating year that were received before the close of the City Council hearing Tuesday, October 8, 2019.

1. The valid written protests received from owners of businesses in the District, pursuant to Section 36524 of the California Streets and Highways Code ("Code"), are as follows:

### VALID WRITTEN PROTESTS RECEIVED

Protests Received: 0 Assessments (Protest Value): \$ 0.00

Pursuant to Section 36525 of the Code, a Majority Protest exists if written protests are received from owners of businesses located in the District which will pay fifty percent (50%) or more of the assessments proposed to be levied.

0 Protest Value \$ 0.00 = 0.0 = 0 (0.0 %) percent protest level.  
Total District Assessments \$ 764,159.22

The tabulation of the valid written protests received **does not** amount to a majority protest, as defined by Section 36525 of the Code. Therefore, the Ordinance authorizing the levying of the special assessments for the District's 2020 operating year **may** be adopted by the City Council.

NOTE: Approximately **1149** Notices, Ordinances of Intention and District Annual Reports were mailed by the City Clerk's Office to all identified business owners in the District on September 23, 2019 and 0 valid written protests were received by the close of the City Council hearing on October 8, 2019, which totaled a 0.0% percent protest level.
