ECONOMIC DEVELOPMENT COMMITTEE REPORT and ORDINANCE OF INTENTION FIRST CONSIDERATION relative to the reconfirmation and assessment increase for the Wilshire Center Merchant-Based Business Improvement District (BID) for 2018.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. FIND that:

- a. The assessments imposed by the Wilshire Center BID for 2018 provide services that directly benefit each of the businesses which pay the assessments.
- b. The services funded by the assessments are provided only to each of the assessed businesses within the boundaries of the BID.
- c. The assessment imposed does not exceed the reasonable cost of conferring the benefits.
- d. The proposed improvements and activities are completely separate from the day to day operations of the City of Los Angeles.
- e. The assessments for the proposed merchant-based BID are not taxes and that the BID qualifies for exemption from Proposition 26 under exemption 1 of Article XIII C Section 1(e)(1).
- f. The services to be provided by the owners' association, Wilshire Center Business Improvement Corporation, are in the nature of professional, expert, technical or other special services, that the services are of a temporary and occasional character, and that the use of competitive bidding would be impractical, not advantageous, undesirable or where the common law otherwise excuses compliance with competitive bidding requirements.
- 2. PRESENT and ADOPT the accompanying ORDINANCE OF INTENTION dated October 2, 2017 confirming the Wilshire Center BID's Annual Report and levying an annual assessment for the Wilshire Center BID's 23rd operating year, January 1, 2018 to December 31, 2018.
- DIRECT the City Clerk to schedule, prepare, publish, and mail the joint notice of public meeting and public hearing, as required by the provisions of Section 36500 et seq. of the California Streets and Highways Code.
- 4. INSTRUCT the City Clerk, subject to the approval of the City Attorney as to form and legality, to prepare and present an enabling Ordinance levying the special assessment for the Wilshire Center BID's 23rd operating period beginning January 1, 2018 to December 31, 2018.
- APPROVE the Wilshire Center Business Improvement Corporation, a California non-profit mutual benefit corporation, to administer the proposed services of the Wilshire Center BID

pursuant to Section 36500 et seq. of the California Streets and Highways Code and City regulations.

- AUTHORIZE the City Clerk, subject to City Attorney approval, to prepare, execute, and administer a contract between the City of Los Angeles and the Wilshire Center BID Corporation to administer the Wilshire Center BID, if the Ordinance reconfirming the BID is adopted.
- 7. APPOINT the Advisory Board Members as listed in the Wilshire Center BID 2018 Annual Report, attached to the October 11, 2017 City Clerk report and the Council File.

<u>Fiscal Impact Statement</u>: The City Clerk reports that this is a merchant-based BID and there are no assessments for City-owned properties within the BID, therefore there is no impact on the General Fund.

Community Impact Statement: None submitted.

Summary:

On October 25, 2017, your Committee considered an October 11, 2017 City Clerk report and Ordinance dated October 2, 2017 relative to the reconfirmation and assessment increase for the Wilshire Center Merchant-Based BID for 2018. According to the City Clerk, on October 31, 1995, Council adopted Ordinance 170755, which established the Wilshire Center BID, located in Council Districts One, Four and Ten (Council File Nos. 94-1949, 99-2168, 04-2480, 06-2513, 09-2715 and 12-1696).

The City is required to conduct reconfirmation proceedings in order to levy a special assessment, which supports each year of District operations. The Wilshire Center BID will complete its 22st operating year on December 31, 2017. The Wilshire Center BID Advisory Board has approved and submitted an Annual Report and is ready to proceed with the reconfirmation of the Wilshire Center BID. The Annual Report for the BID's 23rd operating year, beginning January 1, 2018 through December 31, 2018, is presented as an attachment to the October 11, 2017 City Clerk report and is designated as Attachment 1.

The reconfirmation process consists of the adoption of an Ordinance of Intention, the approval of the Annual Report from the District's management entity and a public meeting and a public hearing prior to the adoption of an Ordinance, which would authorize the special assessment to fund operations for the next year of the program. The City Clerk has received and reviewed the Annual Report as submitted by the Wilshire Center BID Advisory Board and as required by Section 36533 of the California Streets and Highways Code. The report includes the various programs and activities, which would be supported by assessment revenue and interest earnings.

After consideration and having provided an opportunity for public comment, the Committee moved to recommend approval of the recommendations as contained in the October 11, 2017 City Clerk report and detailed in the above recommendations. This matter is now submitted to Council for its consideration.
