
ORDINANCE NO. 182432

An Ordinance amending Ordinance No. 98,921 establishing a building line.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section _. Ordinance No. 98,921; entitled ... An Ordinance ordering the establishment of a building line on the north side of BURBANK BOULEVARD between Sunnyslope Avenue and Greenbush Avenue ... was passed by the Council of the City of Los Angeles at its meeting of November, 1951, ... is hereby amended by <u>repealing</u> the provisions establishing the building line on that portion of BURBANK BOULEVARD, as depicted on the following diagram:



Sec. ____. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Street entrance to the Street entrance to the Los Angeles County Hall of Records.

DECLARATION OF POSTING ORDINANCE
