
PETITION FOR

NAMING / RENAMING COMMUNITY

Pursuant to Council action of January 31, 2006 (Council File 02-0196), a petition must accompany the application to name or rename a community. The petition must contain a minimum of 500 signatures of individuals who either reside in and/or have businesses, both profit and nonprofit, in the neighborhood being name or renamed. If the population of the neighborhood is under 2.500 people, then 20% of the population of the area being named or renamed is required. All addresses will be confirmed as to their location within the boundaries of the community being named/renamed. Therefore, to prevent any delay in the application approval process, it is recommended that additional signatures be collected in case some addresses are not located within the bounded area. Petition for: the Community of ______ (current name of community) to be renamed the Community of (proposed community name). OR the area bounded by the following streets (street boundaries of area to be named) To the North, Southside of De LONGPRE AVE. To the West Westide of VINE St. To the South, Northside of Melrose Ave. To the East, Eastaide of VINE St. to be named the Community of PERU VILLAGE (proposed community name). Peru Village's initiative Fact Sheet

- Peru Village application proposes the official inclusion in the City of Los Angeles of the Peruvian American Community, as there is Thai Town, Little Armenia, Salvadoran Community Corridor.
- Peru Village's March 2013 amended boundaries have drastically reduced the initial proposed area, which
 includes now: Vine St. only between Melrose Ave. (North side) and De Longpre Ave. (South side) in the city of
 Los Angeles as a sign of good faith and acknowledgement to the feedback received.
- The Peruvian community was one of the first communities that migrated to California, since the Gold Rush time, bringing the Peruvian mining expertise.
- The specific Hollywood area has historic significance for Peruvian migrants.
- A large number of Peruvian immigrants, chose California as their US destination in the 60s & 70s and settled in Peru Village's proposed area, establishing in Hollywood the roots of the Peruvian Community in California.
- There are over 120,000 Peruvians in Southern California.
- The Peruvian community is spread throughout Southern California with several concentrated areas including Hollywood within the City Los Angeles.
- There are several well established Peruvian businesses for years in the proposed area.
- Peruvians are a unique Latino subgroup that is a multi-racial, fully assimilated, voting group.
- One of our goals is to help preserve the Hollywood image while taking it into the next century of globalization and trade.
- Another goal is to infuse a sense of community ownership to maintain a clean area that we can all feel proud to live, work and play.
- Provide opportunities for small business owners in order to create jobs and increase the tax base.
- Create a hub for growing international trade and a center for cultural growth and advocacy to help individuals better themselves and the community.
- To assist with the outreach of the latino community as well as their participation.
- 62% of the constituents in this area are Latino including Mexican American, Central American and South American. There is no exact numbers for Peruvians in the area because many identify themselves racially as opposed to ethnically in census studies.
- The City of Los Angeles, which represents over three million residents and prides itself in cultural diversity, aims to include all of its citizens in community affairs; and located in southern California, Los Angeles is one of the world's major global cities, (...) is one of only two United States cities without a majority population. People from 140 countries, who speak approximately 86 languages, currently call Los Angeles home. (Text from Sacramento Bill ACR126 September 9, 2010)
- Naming a geographic area is a fundamental way of expressing cultural values of a community.
- Naming a geographic area after migrant communities is a way to recognize the contributions from those communities to the city and to the USA.
- The Peruvian American Community has greatly contributed to the USA and continues doing so.
- According to a Los Angeles Times article in 2010: "Little Bangladesh' designation is an acknowledgment of the local Bangladeshi presence and recognition that it has been positive, but most stores in the L.A. neighborhood cater to a Latino or Korean clientele."
- According to a Los Angeles Times article in 2009; "only 2% of residents of Thai Town are Thai. Little Ethiopia is less than 1% Ethiopian. Indians make up less than 5% of the part of Artesia known as Little India."
- Over 800 residents and business' owners at the proposed area signed Peru Village's application in support.
- Central Hollywood Neighborhood Council, at its 2/25/13 Board Meeting, unanimously voted in support the designation of Vine from Willoughby to Melrose as Peru Village.
- Senator Durbin from Illinois said: "In the flow of American history, this happens over and over again, when

emerging groups become a political force, they are given respect and recognition under the law, and they become part of the power establishment of America. ... And this is the moment for the Hispanic population."
