To Whom It May Concern:

Our Association has received notice of an application for the creation of a community and community name called Peru Village. On Pages 3 and 85 of the application the southern boundary is proposed to be: "To the south, Melrose Avenue to the south side of the avenue." On the map enclosed with the application (Page 14), the boundary line looks as though it is the north side of Melrose Avenue. We ask that this boundary be modified to reflect the current boundaries of the community and HPOZ of Hancock Park. Our proposed change would be to move the proposed southern boundary of Peru Village, between and including Highland Avenue and Rossmore Avenue, from the south side of Melrose Avenue to the north side of Melrose Avenue.

Hancock Park's boundaries are: Melrose Avenue, south side of the avenue; Rossmore Avenue, both sides of the avenue; Wilshire Blvd., the north side of Wilshire; Highland Avenue, both sides of the Avenue.
