Dear Honorable Members:

For your information, pursuant to Charter Section 508(b), I am appointing Mr. Steven P. Reneker as Permanent General Manager of the Information Technology Agency (ITA), effective as of the date of your confirmation of the appointment, subject to the confirmation of the City Council.

Over the last 25 years, Mr. Reneker has run Information Technology organizations for four different employers which have had Chief Information Officer (CIO) level responsibilities for enterprise wide Information Communications and Technology. Most recently, he has served as the CIO for the City of Riverside, which has been classified as a Top 21 most intelligent community in the world and in 2012 was named most intelligent community in the world by the Intelligent Community Forum (first time a US City has been named in over 10 years).

Prior to that, Mr. Reneker was the Business Development Manager for the Public Safety and Criminal Justice division of Dell Inc. He also worked as the CIO and Director of Information Technology for the County of Riverside, and the City of Aurora, respectively. As Riverside County's first CIO, he brought standards and procurement processes for a decentralized organization. He is highly effective in partnering with business leaders to formulate a strategic view of information technology, and apply new enabling technologies to streamline business processes.

Rebranded web site to provide a simple interface that is easy to navigate, fast to load, and provide on-line access and payment for most City services on-line.

Serve as Executive Director for a non-profit, SmartRiverside, which provides Digital Inclusion to low income families by providing City wide free WiFi, free refurbished PCs (mentoring youth through a gang intervention program) and coordinated free training through RUSD, Alvord and RCOE. Benefited over 5,400 low income families.

Virtualized nearly all servers in the City and reduced the footprint of the City's data center by 50% generating significant power savings. Implemented power management on all Cities PCs to reduce carbon footprint and realize power savings City-wide. Rolled out managed print services to reduce output and route print jobs to the most cost effect devices to reduce City costs.

Lead project management office to focus on the top 25 projects each month out of over 180 projects to ensure resources are allocated properly and executing on the activities that will maximize revenue and operational efficiency.

Established a direction to construct and build an institutional network to connect 225 facilities over 7400 square miles. Through renegotiation of franchise agreements, was able to acquire 250 miles of dark fiber at no cost. Established a direction for VoIP.

Delivered strategic data warehousing solutions for the Sheriff which include: records management, crime analysis, fingerprint, mug shot, and tattoos. This enabled the development of on-line access to Jail inmate visiting and Megan's Law information.
