<u>CLA RECOMMENDATION</u>: Adopt Resolution (Garcetti – Alarcón – Reyes) to include in the City's 2013-2014 Federal Legislative Program, SUPPORT of HR 1217 (Becerra – Ros-Lehtinen), also known as the Smithsonian American Latino Museum Act, which would authorize a plan to create a Smithsonian American Latino Museum.

### **SUMMARY**

On April 3, 2013, Resolution (Garcetti – Alarcón – Reyes) was introduced to support HR 1217 (Becerra – Ros-Lehtinen), also known as the Smithsonian American Latino Museum Act, which would authorize a plan to create a Smithsonian American Latino Museum (Museum). The Resolution advises that the City's history is significantly tied to Latino history and that such a museum would honor this history and the contributions of Latinos throughout the United States of America.

HR 1217 designates the existing Arts and Industries Building of the Smithsonian Institute, located on the National Mall in Washington, D.C., and an adjacent underground annex facility, to be newly constructed, as the future site of the Museum. The bill would provide that the Board of Regents of the Smithsonian Institution, in consultation with the Secretary of the Interior, the Commission of Fine Arts, and the National Capital Planning Commission, as well as other relevant Federal and Local agencies, would prepare plans for design, rehabilitation and construction of the Museum. In terms of funding, HR 1217 would authorize the Board of Regents to identify and evaluation funding options for construction and operation of the Museum. HR 1217 further specifies that the Board of Regents would take into consideration the reports and plans created by a designated commission established by the Commission to Study the Potential Creation of a National Museum of the American Latino Act, which was signed into law in May 2008.

### **BACKGROUND**

In 2007, the Resolution (Garcetti et al.) was adopted to support HR 512 (Becerra) and S 500 (Salazar) that would establish the Commission to Study the Potential Creation of the National Museum of the American Latino, which would be responsible for developing a plan of action for the establishment and maintenance of a National Museum of the American Latino in

Washington, D.C. (C.F. 07-0002-S69). As stated above, the bills were signed into law in May 2008. In 2011, the Commission to Study the Potential Creation of the National Museum of the American Latino issued a report considering various locations for the Museum, including the building presented in HR 1217, and funding options and timelines for the Museum's construction.

## RESOLUTION

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations or policies proposed to or pending before a local, state, or federal governmental body or agency must have been adopted in form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, On March 15, 2013, Congressman Xavier Becerra of California and Congresswoman Ileana Ros-Lehtinen of Florida introduced H.R. 1217, in the 1<sup>st</sup> session of the 113<sup>th</sup> Congress, to establish within the Smithsonian Institution the Smithsonian American Latino Museum; and

WHEREAS, H.R. 1217, also knows as The 'Smithsonian American Latino Museum' Act will authorize a plan of action for the creation of a Smithsonian American Latino Museum; and

WHERE AS, such a museum will honor the contributions and history of Latinos in Los Angeles and the United States of America;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2013-2014 Federal Legislative Program SUPPORT for H.R. 1217 which would establish within the Smithsonian Institution the Smithsonian American Latino Museum.

## A BILL

To establish within the Smithsonian Institution the Smithsonian American Latino Museum, and for other purposes.

- 4 This Act may be cited as the "Smithsonian American
