Dear Los Angeles City Councilmembers,

Physicians for Social Responsibility-Los Angeles (PSR-LA) was pleased that the Englander/Zine Resolution 13-0002-S6, as amended, was unanimously approved by the Rules, Elections, and InterGovernmental Committee on February 22. We strongly urge the full City Council to approve it as well.

PSR-LA has been involved for over twenty years in efforts to get the polluted Santa Susana Field Laboratory (SSFL) fully cleaned up, and strongly supports the Administrative Order on Consent (AOC) entered into in 2010 by the California Department of Toxic Substances Control (DTSC) and NASA to clean up NASA's portion of the site to background. That cleanup agreement and a similar one entered into with the Department of Energy were a result in part of successful litigation brought by the City of Los Angeles, along with the Natural Resources Defense Council and the Committee to Bridge the Gap.

Any transfer of ownership of NASA's property prior to cleanup could jeopardize this cleanup, and therefore threaten the public health of nearby communities and Southern California. The contaminants include TCE, perchlorate, dioxins, heavy metals, and other volatile and semi-volatile organics. When it rains or the wind blows, contaminants from the site can be released into the neighboring communities of the City of Los Angeles. Public health studies have identified elevated rates of certain cancers in the nearby population associated with proximity to the site.

The only way to ensure that public health is protected from the contaminants at SSFL is a remediation of the site to background levels of contamination as NASA agreed to do. Premature transfer of that land, before completion of the AOC-mandated cleanup, could put that cleanup in jeopardy. The County of Ventura and the City of Simi Valley have already passed resolutions to the one before you now. PSR-LA strongly supports the resolution introduced by Councilmen Englander and Zine, as amended, for the City of Los Angeles to oppose transfer of NASA's property at SSFL until the site is completely cleaned up.

Dear LA City Councilmembers,

The Southern California Federation of Scientists, SCFS, strongly supports the resolution introduced by Councilmen Englander and Zine (13-0002-S6) for the City of Los Angeles to oppose transfer of NASA's property at the SSFL until the site is completely cleaned up. We were pleased the resolution, as amended, was approved by the Rules, Elections and Intergovernmental Relations Committee, and urge you to vote to approve the resolution when it comes before the full City Council.

Founded shortly after the Second World War by former Manhattan Project scientists, SCFS is an interdisciplinary organization of scientists, engineers, scholars and concerned citizens dedicated to providing independent scientific and technical analyses and expertise on issues affecting science, society and public policy. SCFS has been involved in the cleanup of the Santa Susana Field Laboratory (SSFL) for over three decades, providing comment and analysis on the site's contamination and potential impact on the surrounding area and on the pressing need for full cleanup.

NASA's property at SSFL is contaminated by pollutants that can produce serious health consequences and which can migrate, as in the case of stormwater leaving the facility which has routinely violated permissible concentrations of pollutants resulting in scores of violations cited by regulators. Migration by surface water, groundwater, or airborne contamination has been found to have left the facility boundaries. Full cleanup is essential to protecting the residents of the City of Los Angeles and other communities living and working in the region nearby.

In 2010, NASA entered into an agreement on consent with the Department of Toxic Substances Control that requires cleanup to background levels of contamination, a sensible and scientifically appropriate standard given the significant contamination at the site. A transfer of the property prior to cleanup puts at risk this important agreement and thus public health.

We strongly support the Englander/Zine resolution and urge you to do the same.

Dear Councilmember Garcetti,

ACME (Aerospace Contamination Museum of Education) is in full support of Councilmember Englander's resolution (MOT 13-0002-S6), seconded by Councilmember Zine, regarding cleanup of the contaminated Santa Susana Field Laboratory (SSFL). Efforts to transfer the land, for whatever purpose, before full cleanup has been completed can interfere with or block that full cleanup. NASA has entered into an Agreement on Consent (AOC) with California to clean up all contamination above background. Efforts to transfer the land should not occur until the AOC cleanup is complete.

A similar resolution was recently passed by the Ventura County Board of Supervisors. We support the resolution in part because it addresses the environmental contamination at the headwaters of the Los Angeles River which begin near the ALFA test stands in the NASA/GSA-controlled portion of the Santa Susana Field Laboratory.

We fear that any change in ownership of NASA's land prior to it being fully cleaned up pursuant to the cleanup agreements, including to the Santa Ynez Band of Chumash Indians who might not be subject to the state-federal cleanup agreement, or to any other entity, would open the door to the possibility that the contamination would not be fully cleaned up and therefore continue to threaten our communities. No transfer to any entity, private or public, should be considered until completion of the cleanup to the AOC requirements.

Thank you for your time and consideration, to help ensure a proper cleanup of the Santa Susana Field Laboratory.
