WHEREAS, Ryan Rossi and J.R. Richards started 20K Watts, an international nonprofit dedicated to enhancing the current and future quality of life of children, and their families, living in extreme poverty through the use of solar and renewable energies; and

WHEREAS, 20K Watts is powering community development projects that promote children's education, clean water, sanitation, health, economic development, food, security, and solar lamps that eliminate toxic kerosene and biomass fumes; and

WHEREAS, After receiving e-mails from members of the Peace Corps. of the United States stationed in El Salvador that loved their music, Ryan and J.R. performed music that provided comfort and support to those working and living in El Salvador. Ryan and J.R. made an impromptu trip to El Salvador to play music, comfort the locals and experience life in a third-world country first-hand; and

WHEREAS, After witnessing the horrific living conditions, including a visit to a remote village in El Salvador where 50 to 60 children contracted respiratory illnesses and cancer from kerosene and biomass fumes, Ryan and JR returned to Los Angeles to figure out a way to assist these children. By performing concerts where all proceeds went to purchasing solar lamps to replace kerosene lamps and candles that are harming children, 20K Watts was born and delivered the first 250 solar lamps in spring of 2011; and

WHEREAS, In March 2011, Ryan was diagnosed with non-hodgkins lymphoma; and

WHEREAS, Lymphoma did not stop Ryan from continuing his work, writing music and being a leader with 20K Watts. Knowing his fate, Ryan dedicated the rest of his life and legacy to continue to assist children living in extreme poverty worldwide; and

WHEREAS, Ryan passed away from lymphoma in December 2011; and

WHEREAS, The Rossi family and dedicated friends and colleagues are thoroughly committed to continuing Ryan's work and legacy with 20K Watts; and

WHEREAS, To date 20K Watts has implemented over 2000 solar lanterns in villages in El Salvador, Honduras and Mexico with upcoming initiatives in Zambia and Nepal; and

WHEREAS, 20K Watts has installed 3 solar powered refrigerators in remote clinics in the remote villages of El Salvador; and

WHEREAS, 20K Watts has implemented a solar power system in a school located at San Sebastián El Salvador so teachers have light and power for audio visual systems to teach students, keep them interested, increase literacy and decrease dropout rates; and

WHEREAS, 20K Watts has set up a power system with solar and LED lighting and a complete power unit for a remote village in central El Salvador; and

NOW, THEREFORE, BE IT RESOLVED, that by the adoption of this resolution, the Los Angeles City Council does hereby commend and recognize the efforts of Ryan Rossi and everyone committed to the efforts of 20K Watts for providing a better quality of life for children and their families worldwide on behalf of the City of Los Angeles.
