PUBLIC SAFETY COMMITTEE REPORT relative to the donation of funding for use by the Los Angeles Police Department (LAPD) for a study on driving under the influence (DUI) patterns to be conducted by the University of California at Los Angeles (UCLA) Luskin School of Public Affairs.

Recommendation for Council action:

AUTHORIZE the LAPD to accept the donation of funding in the amount of \$60,000 from the Los Angeles Police Foundation for use by the LAPD for a study on DUI patterns to be conducted by the UCLA Luskin School of Public Affairs, and THANK the donor for this generous gift.

Fiscal Impact Statement: None submitted by the LAPD. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

SUMMARY

In a report to the Board of Police Commissioners dated September 27, 2013 (attached to the Council file), LAPD requests authority to accept a donation of funding for a study on DUI patterns. LAPD reports that the study will analyze the thesis question, "Are DUI arrestees with prior violent criminal history more likely than other DUI arrestees to cause death or injury in future motor vehicle crashes?" The study's findings will impact current policies by recommending either more or less aggressive criminal filing depending on the arrestee's prior history. On October 8, 2013, the Board approved LAPD's request.

At its meeting held November 8, 2013, the Public Safety Committee recommended that Council authorize LAPD to accept this donation and thank the donor for this generous gift.
