DISCUSSION

Dr. Craig D. Uchida will continue to work with the Los Angeles Police Department on Operation Los Angeles' Strategic Extraction and Restoration (LASER) program which focuses on gun related and violent crime related hot spots and chronic offenders. Dr. Uchida serves as facilitator and evaluator of Operation LASER. Operation LASER is part of the Smart Policing Initiative that is funded by the Bureau of Justice Assistance, United States Department of Justice.

No expressed or implied commitments or promises were made to the donor or representatives of the donor. The donor will not receive any preferential treatment, endorsement, or recommendation; and the donor is not allowed the use of any Los Angeles Police Department patents.
