DISCUSSION

The donation will be utilized by the Off Road Unit, which provides enforcement in the mountains throughout the City of Los Angeles. The trailer is a custom 8.5 feet by 22 feet Special Operations tag-a-long from TPD Trailers Incorporated.

On November 20, 2012, Director of Transportation, Vartan Yeghyan, agreed to add the trailer to the Los Angeles Police Department's fleet. No expressed or implied commitments or promises were made to the donor or representatives of the donor. The donor will not receive any preferential treatment, endorsement, or recommendation; and the donor is not allowed the use of any Los Angeles Police Department patents.

Administrative Services Bureau has reviewed the donation and determined that it has been submitted in accordance with Section 5.467 et seq. of the Los Angeles Administrative Code, which provides for the receipt and acceptance of donations to the Los Angeles Police Department.
