COMMUNICATION FROM CHAIR AND MEMBER, PUBLIC SAFETY COMMITTEE relative to the donation of various military items for use by the Los Angeles Police Department (LAPD).

Recommendation for Council action:

AUTHORIZE LAPD to accept the donation of various military items valued at \$70,996.11 from the Federal Excess Property 1033 Program, and THANK the donor for this generous gift.

Fiscal Impact Statement: None submitted by LAPD. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

SUMMARY

In a report to the Board of Police Commissioners dated April 19, 2013 (attached to the Council file), LAPD requests authority to accept a donation of various military items from the Federal Excess Property 1033 Program. LAPD will distribute the resources to specialized Department units throughout the city. The Board approved LAPD's request.

At the Public Safety Committee meeting held May 24, 2013, the Public Safety Committee recommended that Council authorize LAPD to accept this donation, as recommended by the Board of Police Commissioners.
