ORDINANCE NO. 184767

An ordinance amending the Los Angeles Municipal Code to add a new Subsection (e) to Section 46.30 of Article 6.7, Chapter IV, which adds a sunset date of July 1, 2017 to the ordinance banning the possession of large-capacity ammunition magazines.

## THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. Subsection (e) of Section 46.30 of Article 6.7, Chapter IV of the Los Angeles Municipal Code is renumbered to be Subsection (f).

Sec. 2. A new Subsection (e) is added to Section 46.30, Article 6.7 of Chapter IV of the Los Angeles Municipal Code to read as follows:

(e) This Section shall expire on July 1, 2017, unless the City Council acts by ordinance to amend this Section to extend its effective period.

Sec. 3. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
