The City Council ADOPTED the following recommendation(s), contained in COMMUNICATIONS FROM THE BOARD OF WATER AND POWER COMMISSIONERS AND THE CITY ATTORNEY which were WAIVED, pursuant to Council Rule 17, by the Chair of the Energy and Environment Committee, SUBJECT TO THE APPROVAL OF THE MAYOR:

- 1. FIND that in accordance with Section 15277 of the California Environmental Quality Act (CEQA), the Mohave Generating Station is located in Arizona and subject to the National Environmental Policy Act, and, therefore, expenditures relating to this project are not subject to CEQA.
- 2. PRESENT and ADOPT the accompanying ORDINANCE approving a Resolution of the Board of Water and Power Commissioners for the allocation and expenditure of \$136,100 for costs, expenses and any emergent work identified within the Mohave Generating Station Budget for 2013.
- 3. CONCUR with the Board of Water and Power Commissioners' action of January 25, 2013, approved as to form and legality by the City Attorney, Resolution No. 013-171, authorizing payments up to \$136,100 for the Los Angeles Department of Water and Power's Administrative and Maintenance Budget for the Mohave Generating Station Fiscal Year 2013.
