Retroactive Acceptance of the Sub-Recipient Grant Award of \$100,000 from the U.S. Department of Commerce, Minority Business Development Agency (MBDA) to operate the Minority Business Center – Los Angeles (MBC-LA) for Program Year Three, effective April 1, 2013 through March 31, 2014

#### Honorable Members:

In November 2010, the Mayor's Office of Housing and Economic Development and the University of Southern California Government and Civic Engagement (USC-GCE) submitted a joint application for the 2011 Minority Business Center (MBC) Program Grant to the U.S Department of Commerce, Minority Business Development Agency (MBDA). USC-GCE (primary) and the City (sub-recipient) executed and submitted a contractual agreement as part of the application process. The City was awarded a sub-recipient award in the amount of \$500,000, or \$100,000 annually over a five-year period effective April 1, 2011 through March 31, 2016. The Mayor's Office requests approval to accept the 2014 MBDA Business Center Program grant funds in the amount of \$100,000 for the third program year, commencing April 1, 2013 to March 31, 2014. The Mayor's Office also requests acceptance of all program revenue generated through client fees and contributions.

Since 1994, the Minority Business Center–Los Angeles (MBC-LA), formerly known as Los Angeles Minority Business Opportunity Center (LA MBOC), has performed a key role in promoting the growth and global competiveness of the minority business enterprise community. The overall goal of the MBC Program is to stimulate business development, job creation and enhance the long-term growth and self-sufficiency of minority businesses. MBC-LA offers technical assistance, strategic contract and procurement opportunities, business development consulting services and educational forums.

USC-GCE and the City of Los Angeles work together to collaborate on all special events, committees and outreach activities pertaining to the Center program, with the exception of the Annual Minority Enterprise Development (MED) Week Awards events. The City is solely responsible for the MED Week event. The goal of this event is to recognize and promote the achievements of minority-owned business enterprises. This MED Week event also serves as a fundraising vehicle through the solicitation of corporation sponsorships and to provide year round financial support for program services.

The entire MBDA Grant sub-award in the amount of \$100,000 will be utilized for salary costs as discussed below. The other operating expenses such as supplies, travel and contractual services will be funded by client fees and third party cash contributions.

The MBC-LA staffing consists of five full-time positions. However, only two of the four full-time positions (Mayoral Aide V and Mayoral Aide VI) work 100 percent of their time on the MBDA program and 67 percent of their salaries which is \$98,249 is allocated toward the MBDA Grant. The remaining 33 percent of their salaries in the amount of \$48,391 is subsidized by the Mayor's Office 2013-14 Adopted Budget as part of the City cost share commitment under the subcontract agreement to operate the MBDA Business Center. The 10 percent of the salaries of the full-time Mayoral Aide VIII position, which is now vacant, is allocated toward the MBDA Grant, and the remaining portion of the salaries in the amount of \$15,549 is subsidized by the Mayor's Office 2013-14 Adopted Budget. The other two full-time positions (Mayoral Aide III and Mayoral Aide V) contribute 50 percent of their working hours to the MBDA program as part of the City's cost share commitment. This portion of their salaries totaling \$71,048 is subsidized by the Mayor's Office 2013-14 Adopted Budget. The total matching amount for Program Year Three is \$134,988 as shown below:

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

- 1. - 3. AUTHORIZE the Controller to:

- 5. Authorize the Mayor's Office to prepare Controller's instructions for any necessary technical adjustments, subject to the approval of the City Administrative Officer, and authorize the Controller to implement the instructions.

# Fiscal Impact Statement

There is no additional impact to the General Fund relative to the retroactive acceptance of the 2013-14 MBDA Business Center Program Grant sub-allocation from USC-GCE. The Program Year Three total program cost is projected to be \$269,198. Of that amount, \$134,210 in salary costs and expenses will be reimbursed by the MBDA Grant, program income and contributions, with the balance of \$134,988 in salary costs funded by the Mayor's Office 2013-14 Adopted Budget.

# CONTRACTUAL AGREEMENT BETWEEN UNIVERSITY OF SOUTHERN CALIFORNIA GOVERNMENT AND CIVIC ENGAGEMENT AND CITY OF LOS ANGELES, MAYOR'S OFFICE OF ECONOMIC AND BUSINESS POLICY

January 5, 2011

This contractual agreement is hereby made and entered into by and between the University of Southern California Government and Civic Engagement (USC-GCE) and the City of Los Angeles, Mayor's Office of Economic & Business Policy (OEBP).

This contractual agreement is to outline the terms of this partnership for University of Southern California to submit an application for funding to operate the Minority Business Development Agency (MBDA) Business Center in Los Angeles. Under this agreement USC-GCE is the applicant therefore, USC will serve as the lead and operator for the MBC program. Sergio Gascon, Executive Director of Minority Business Enterprise Center USC, will be the Executive Project Director and responsible for comprehensive oversight, general delivery of all program services.

The total grant award will be \$365,000 each year for a period of 5 years and of this amount the City of Los Angeles OEBP shall receive \$100,000 each year for a period of 5 years as a contractual consultant as outline in the budget. The City is to provide services in the area of government and private sector procurement as its primary function. The City of Los Angeles OEBP shall be required to achieve at least 30% of the Project's Estimated Total Value of Awarded Transactions Goal as follows:

Terms of this Contractual Agreement shall be April 1, 2011 to March 31, 2016 and is contingent upon award and acceptance of the MBDA grant. This agreement cannot be amended or include additional addendums. The contractual agreement contains terms and conditions mutually acceptable to each of the parties and upon execution, is binding as it relates to the various ways in which USC-GCE and City of Los Angeles OEBP agree to perform in the manner set forth below:

- USC will maintain full leadership as the lead operator of the program and provide guidance to The City of Los Angeles OEBP in execution of this agreement.
- USC and The City of Los Angeles OEBP will work together to collaborate on all outreach special events, committees, network outreach pertaining to the MBC program under USC's guidance and direction.
- USC and The City of Los Angeles OEBP (Sub-Contractor) will recruit 30% of each year's Total Client Served goal of eligible minority enterprises. Year 1 total goal is 60 clients and Year 2-5 total goal is 75 clients each year. USC will do the remaining 70%.
- USC and The City of Los Angeles OEBP shall provide monthly report outcomes on the 30<sup>th</sup> of each month to include a pipeline (work in progress) report to the Executive Project Director. Reporting will start 30 days after the award is received.
- USC-GCE shall receive program income as agreed by the City of Los Angeles, as per the following:

- All communications, reporting and accessing the portal system must be done through USC as the MBC Operator.
- All documentation on closed transactions must be submitted to USC within 48
  hours of transactions closing date. USC as the operator must input all
  transactions in compliance with MBDA requirements.
- USC-GCE shall coordinate weekly meetings to ensure performance is on target and all terms are satisfied.

The foregoing terms of this Contractual Agreement are hereby accepted.
