REQUEST FOR ORDINANCE

At a joint special meeting held on April 9, 2013, the Planning and Land Use Management (PLUM) Committee and the Trade, Commerce and Tourism (TCT) Committee considered the following:

Final Environmental Impact Report (FEIR), Mitigation, Monitoring and Reporting Program, California Environmental Quality Act (CEQA) Findings and Statement of Overriding Considerations and reports from the Mayor, Los Angeles Board of Airport Commissioners, Los Angeles City Planning Commission and Resolutions relative to the Los Angeles International Airport (LAX) Specific Plan Amendment Study, the Staff-Recommended Alternative as the best alternative to the problems that the Yellow Light Projects were designed to address and which shall be subject to further planning, engineering and project-level environmental review under CEQA and subject to final evaluation and approval by the Federal Aviation Administration; and proposed amendments to the LAX Specific Plan and to the City of Los Angeles General Plan, including amendments to the LAX Plan, the Westchester-Playa Del Rey Community Plan, Noise Element and Transportation Element of the General Plan, for LAX and surrounding area, generally bounded by the Westches er - Playa Del Rey Community Plan Area to the north and east, the City of Inglewood to the east, the City of El Segundo to the south, and Dockweiler State Beach to the west, and proposed amendments to the LAX Specific Plan.

At this meeting, the PLUM and TCT Committees requested that the City Attorney prepare and present an ordinance for the LAX Specific Plan.
