SUMMARY

At a regular meeting held on June 5, 2013, the Chair of the Housing, Community and Economic Development Committee considered Motion (Perry - Parks) relative to authorization to use \$25,000 in UDAG savings, from the Los Angeles Homeless Services Authority Homeless Count, for Sustainable Economic Enterprises of Los Angeles (SEE-LA) in support of the Central Avenue Farmers' Market; authorization to negotiate and execute an agreement with SEE-LA; and related actions. However, this Motion was superseded by subsequent Motion (Perry – Huizar) dated May 14, 2013, attached to Council File No. 13-0346-S1.
