BUDGET AND FINANCE COMMITTEE REPORT and ORDINANCE FIRST CONSIDERATION relative to amending the Los Angeles Administrative Code (LAAC) to create and provide for the administration of the Council District 5 Avenue of the Stars Community Amenities Trust Fund.

Recommendation for Council Action, SUBJECT TO THE APPROVAL OF THE MAYOR:

PRESENT and ADOPT the accompanying Ordinance amending the LAAC to add a new Chapter 161 to Division 5 to create and provide for the administration of the Council District 5 Avenue of the Stars Community Amenities Trust Fund.
