4. Motion by Erick Mansker, second by Bonnie Burshk to purchase additional lights for the Veteran's Memorial Park tree, NTE \$2000. Motion carried, 14/0/1..
5. Motion by Eric Mansker, second by Jerry Askew to support the designation of the area between the 405 freeway, Balboa Blvd., Devonshire St. and Lassen St. from North Hills to Granada Hills. Motion carried unanimously.
6. Motion by Dr. Bob Lusczak, second by Eric Mansker to disapprove a permanent addition of bike lanes on White Oak Ave. between Devonshire and Rinaldi. Motion carried, 14/0/1.
7. Board confirmation of the appointment of Sally Kolstad as Education Director and Chair of the Education committee, effective upon the resignation of Julie Carson. Motion made by Bonnie Bursk, second by Art Daush. Motion carried unanimously.

Outreach Committttee (Jett Dunlap)

Rescheduling of Movie Night in the Park was discussed. A new date and funding request will be on the September agenda.

Pole banners are along all the major streets in South Granada Hills. There are 20 banners, with 10 in reserve and they are slit to minimize wind damage.

4. Definition of Recycling Centers for inclusion in the specific plan.
5. Request a detailed review of all "Q" conditions in OS or higher zones that are scheduled for removal in the updated specific plan, including citations to LAMC that will place the same restrictions currently provided by "Q" conditions in the current specific plan. Motion carried, 14/0/2.
6. Adopt the position of the Pacific Palisades Community Council (attached) regarding the pending mural ordinance and forward same to Los Angeles City PLUM Committee. Motion carried unanimously with amendment to make it clear that GHSNC supports the "opt in" option,
7. Adopt the position of the Pacific Palisades Community Council (attached) regarding above ground facilities. Motion carried unanimously.
