PUBLIC SAFETY COMMITTEE REPORT relative to a Fiscal Year (FY) 2012 Emergency Management Performance grant award for use by the Emergency Management Department (EMD).

Recommendation for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

AUTHORIZE the General Manager, EMD, or designee, to:

- 1. Accept the FY 2012 Emergency Management Performance grant award from the Federal Emergency Management Agency in the amount of \$607,139, with a grant performance period of July 1, 2012 to June 30, 2013.
- Execute the sub-recipient agreement, (Attachment B to the EMD report to Council dated April 29, 2103, attached to the Council file) between the City of Los Angeles and the County of Los Angeles, for the acceptance of the FY 2012 Emergency Management Performance grant, subject to the approval of the City Attorney as to form and legality.
- 3. Deposit the grant funds received under the sub-recipient agreement into the General Fund 100/35, Revenue Source Code 3702 "Emergency Management Assistance."
- 4. Prepare Controller instructions for any technical adjustments, subject to the approval of the City Administrative Officer (CAO); and, AUTHORIZE the Controller to implement the instructions.

<u>Fiscal Impact Statement</u>: The CAO reports that this action will not impact the General Fund. Grant funds will be used to support the City's emergency management programs. The above recommendations are in compliance with City financial policies in that grant funds are sufficient to support the grant activities.

Community Impact Statement: None submitted.

## <u>SUMMARY</u>

In a report to the Mayor and Council dated September 5, 2013 (attached to the Council file), the CAO states that the EMD requests authority to accept the FY 2012 Emergency Management Performance grant award in the amount of \$607,139 from the Department of Homeland Security for the grant performance period of July 1, 2012 to June 30, 2013. The EMD also requests authority to execute a sub-recipient agreement with the County of Los Angeles to receive the City's portion of this grant award.

According to the CAO, the Emergency Management Performance grant requires a dollar for dollar match that the City has met through General Funded emergency management expenses. The purpose of the Emergency Management Performance grant is to sustain and improve comprehensive emergency management programs at the state, tribal, and local levels from all man-made and natural disasters through the prevention, mitigation, response, and recovery of all hazards events. The CAO recommends approval of EMD's requests.

At its meeting held September 13, 2013, the Public Safety Committee recommended that Council

authorize the EMD to accept this grant award, and to approve the related actions above, as recommended by the CAO.
