I HEREBY MOVE that the Council ADOPT the following recommendations of the City Attorney in order to effect settlement in the case entitled Margie Carranza and Emma Hernandez v. City of Los Angeles, Claim No. C13-3426. (This matter involves an incident which occurred on February 7, 2013 involving members of the Los Angeles Police Department), **SUBJECT TO THE APPROVAL OF THE MAYOR:**

1. AUTHORIZE the City Attorney to pay a total of \$4,200,000 in settlement of the above-entitled matter from City Attorney, Fund 100, Department 59, Account No. 009770.
2. AUTHORIZE the City Attorney to draw demands thereon as follows:
 - a. \$2,100,000 made payable to Jonas & Driscoll, LLP and Margie Carranza
 - b. \$2,100,000 made payable to Jonas & Driscoll, LLP and Emma Hernandez
3. AUTHORIZE the City Attorney, or designee, to prepare Controller instructions for any necessary technical adjustments, subject to the approval of the City Administrative Officer, and AUTHORIZE the Controller to implement the instructions.
