GENERAL EXEMPTION, COMMUNICATION FROM CHAIR, ENERGY AND ENVIRONMENT COMMITTEE relative to Agreement No. 47183-3 with OS1soft, LLC for the PI Historian Systems Maintenance Program.

Recommendations for Council action:

1. FIND that this action is exempt from the California Environmental Quality Act (CEQA) pursuant to the General Exemption as described in Section No. 15061(b)(3) of the Los Angeles City CEQA Guidelines.
2. CONCUR with the Board of Water and Power Commissioner's action of May 24, 2013 by Resolution No. 013278, authorizing the execution of the proposed Agreement No. 47183-3 with OS1soft, LLC for the PI Historian Systems Maintenance Program.

Fiscal Impact Statement: The City Administrative Officer reports that approval of the Agreement with OS1soft, Inc. will have no impact on the General Fund. All expenditures for this Agreement will be from the Los Angeles Department of Water and Power's (LADWP) Power Revenue Fund over a five year period. The LADWP Debt Management Policies do not apply.
