- 2. APPROVE the proposed modifications to the PY 2013-14 WIB Annual Plan budget.
- 3. AUTHORIZE the General Manager, Economic and Workforce Development Department (EWDD), or designee, to accept on behalf of the City \$150,000 in TAACCCT Grant funds from the Los Angeles Community College District.
- 4. AUTHORIZE the Controller to establish a new interest-bearing fund called Trade Adjustment Assistance Community College and Career Training (TAACCCT) Grant Fund No. XXX.
- 5. AUTHORIZE the Controller to implement the Controller instructions found in the attachment to the City Administrative Officer (CAO) report dated April 7, 2014 (attached to Council file No. 13-0728-S3).
- 6. AUTHORIZE the General Manager, EWDD, or designee, to prepare additional Controller instructions and any technical adjustments that are consistent with Mayor and Council action regarding this matter, subject to approval by the CAO; and AUTHORIZE the Controller to implement the instructions.
