I understand that, based on California law, I have a community property interest in the Santa Monica Body Craft Center, LLC, ("SMBCC") a California limited liability company with it primary business address at 1665 11th Street, Santa Monica CA 90401. SMBCC operates an automobile body repair facility at the foregoing address. City of Santa Monica Business License #153783; State of California, Bureau of Automotive Repair Registration # ARD00271808.

NOW, THEREFORE, I make the following Waiver of Community Property, pursuant to California Family Code §850(a), §851 and §852:
