Re: Addendum to Transmittal for the Fiscal Year 2010 Regional Catastrophic Preparedness Grant Program (FY10 RCPGP) Budget Modifications and Contracting Authorities (Council File Nos. 13-0798-S1 and 10-1954)

Dear Honorable Members:

Transmitted herewith for City Council consideration is an addendum to the original report dated July 22, 2013, requesting approval of the revised budget modifications and contracting authorities for the Fiscal Year 2010 Regional Catastrophic Preparedness Grant Program (FY10 RCPGP).

The original transmittal outlined an increased allocation to the American Red Cross of \$240,000 for a two phase planning and assessment project. Since then, the American Red Cross has declined \$130,000 due to revised project budgets and problems meeting the grant match requirement. The City of San Bernardino has also returned an additional \$1,899 of their Alliance planner salaries.

The returned funds will be allocated to the City of Los Angeles Emergency Management Department's step-by-step disaster recovery handbook for disaster survivors entitled, *The Red Guide to Recovery, Resource Handbook for Disaster Survivors (Red Guide)*, for a total project amount of \$500,000. Attached is an updated FY10 RCPGP grant budget (Attachment 1).

Recommendations

It is, therefore, requested that the City Council:





1. Authorize the Mayor, or his designee, to:

- a. Modify the existing grant budget for the Fiscal Year 2010 Regional Catastrophic Preparedness Grant Program by reallocating funds between agencies as described within the report and as detailed in Attachment 1;
- b. Negotiate and execute contract amendments with the County of Los Angeles, City of Riverside, City of San Bernardino, County of San Bernardino, County of Ventura, City of Ontario, and the American Red Cross for the purpose of revising FY10 RCPGP allocations and match requirements as applicable in accordance with the revised FY10 RCPGP budget (Attachment 1), subject to the approval of the City Attorney as to form and legality;
- c. Negotiate and execute on behalf of the City, a sole source contract with Mr. Sean Scott, or his affiliates, for an amount not to exceed \$500,000 for the disaster recovery handbook project for a term not to exceed 3 months, subject to the approval of the City Attorney as to form and legality; and
- d. Negotiate and execute on behalf of the City, a contract for the development of a database to manage the City departments' emergency plans and continuity of operations plans, for an amount not to exceed \$55,000, and for a term not to exceed 3 months, subject to the approval of the City Attorney as to form and legality.

2. Authorize the Controller, or designee, to:



<u>Fiscal Year 2010 Regional Catastrophic Preparedness Grant Program (FY10 RCPGP) Budget Modifications and Contracting Authorities (Council File No. 10-1954)</u>

Dear Honorable Members:

Transmitted herewith for City Council consideration are proposed budget modifications and contracting authorities to the United States Department of Homeland Security (DHS) Fiscal Year 2010 Regional Catastrophic Preparedness Grant Program (FY10 RCPGP) award. On December 6, 2011, the City Council formally accepted the FY10 RCPGP grant for \$3,570,000 (Council File No. 10-1954). On February 8, 2013, the California Emergency Management Agency (CalEMA) extended the period of performance from April 30, 2013 to June 30, 2013, and subsequent to receiving the extension approval, on April 12, 2013, CalEMA approved an extension to September 30, 2013.

Due to regional partners' inability to meet grant match requirements or other technical and budgetary issues, several jurisdictions have declined or returned their allocated amounts for FY10 RCPGP. Although the Mayor's Office has sought a waiver for the match requirement on multiple occasions from the Grantor, the waiver has not been granted. In the Mayor's Report dated October 3, 2012 (Council File No. 10-1954), an amount of \$62,714 was pending to be reallocated, and since that report, additional funding totaling \$835,716 was returned by Los Angeles County, City of Riverside, City of San Bernardino, County of San Bernardino, County of Ventura and City of Ontario.

The total amount returned of \$898,430 was reallocated to the City of Los Angeles Emergency Management Department (\$498,191), the City of Los Angeles Housing Department (\$13,225), the County of Los Angeles Sheriff's Department (\$100,000) and the American Red Cross (\$287,014). A revised FY10 RCPGP grant budget can be found in Attachment 1.

City of Los Angeles Emergency Management Department

The City of Los Angeles Emergency Management Department (EMD) will receive an allocation of \$498,191 of returned funding. In order to help complete the planning projects for this grant year, specifically the development of the Recovery guide and template, \$275,000 will be allocated to their salary allocation. Because numerous jurisdictions and departments originally assigned to work on these planning projects have had to return all or part of their funding, the number of those involved in the planning efforts has been reduced significantly. This has created an increased work load for those members still actively involved and consequently, the timeframe, and the salary allocation to those departments still working on this project, have had to expand to accommodate these changes.

The remaining amount of \$223,191 is being allocated for the design and publication of a step-by-step disaster recovery handbook for disaster survivors entitled, *The Red Guide to Recovery, Resource Handbook for Disaster Survivors (Red Guide)*. In addition, cost savings from EMD's Local Hazard Mitigation Plan (LHMP) and Department Emergency Plan (DEP) project in the amount of \$145,000 was reallocated to the Red Guide for a total project amount of \$368,191. The Red Guide will have details related to geography, services, jurisdictional boundaries and contact information which will be formatted to address services and programs specific to the Los Angeles area. The guide will be printed in numerous languages including English, Spanish, large print and Braille. This project received sole source grantor approval on July 2, 2013. The sole source contractor, Sean Scott, has copyright (2011) of the material and publication.

The additional match requirement of approximately \$174,804 will be met by EMD through fringe benefit costs and by utilizing existing regular authority staff members to work on this grant funded program. Authority is being requested to conduct necessary fiscal transfers and to negotiate and execute a contract for an initial amount of \$368,191, with Sean Scott, or his affiliates, for the development and publication of the Red Guide.

With cost savings being moved to the Red Guide, EMD's Local Hazard Mitigation Plan (LHMP) and Department Emergency Plan (DEP) project (referenced above) has a remaining allocated amount of \$105,000. The \$105,000 will be used towards two contracts. The first contract received contracting authority in the Mayor's Report, dated October 3, 2012 and will focus on the LHMP portion of the project. EMD is now requesting contracting authority for the development and expansion of the DEP portion,

through the design and development of a software system solution to manage City DEPs as well as continuity of operations plans (COOP). This project includes the development of an electronic database system which would house all DEPs and COOPs, provide City departments intranet access via EMD's existing intranet site to download/upload DEPs and COOPs, and allow for viewing, revisions, submissions, approval and certifications of such plans via the software. Authority is being requested to negotiate and execute a contract for an amount not to exceed \$55,000 for the design and development of a software system solution to manage the City's DEPs and COOPs.

City of Los Angeles Housing Department

The City of Los Angeles Housing Department (LAHD) will receive an additional allocation of \$13,225 which will be utilized for their Regional Disaster Housing Project. In addition, LAHD identified cost savings totaling \$5,898 from their travel and contract projects and are reallocating the cost savings towards their Regional Disaster Housing Project. The additional match requirement of approximately \$4,640 will be met by LAHD through fringe benefit costs and by utilizing existing regular authority staff members to work on this grant funded program. Authority is being requested to conduct necessary fiscal transfers.

County of Los Angeles Sheriff's Department

The County of Los Angeles Sheriff's Department will receive an increased grant allocation of \$100,000 of returned funding in order to help complete the planning projects for this grant year, specifically the development of the Recovery guide and template. Because numerous jurisdictions and departments originally assigned to work on these planning projects have had to return all or part of their funding, the number of those involved in the planning efforts has been reduced significantly. This has created an increased work load for those members still actively involved and consequently, the timeframe, and the salary allocation to those departments still working on this project, have had to expand to accommodate these changes.

American Red Cross

The American Red Cross (ARC), Los Angeles Chapter will receive an increased grant allocation of \$287,014. Of this amount, a total amount of \$240,000 will be used by ARC to conduct a two phase planning and assessment project to formally identify, build and maintain strategic partnerships with key nongovernmental and faith-based organizations, and to identify and maintain a target list of the most underserved and vulnerable communities throughout the region. The remaining amount of \$47,014 will be utilized by the ARC to conduct an Emergency Operations Center (EOC) Planning and Operations training, and to develop a training plan. Authority is being requested to execute a contract amendment to reflect an increase of the total contract amount by \$287,014.
